- Have a meeting at the CDA in Eagan with himself and Nicole and finding out what grant money is available if any to try and get Hogan Ave fixed.
- Since New Trier is now classified a low income city the city itself is open to a lot more grants and special funding. He said he would help us mitigate that process.
- Mike also wanted to make sure the council was aware of the speed change going from 30 to 40mph coming into the city off Hwy 85. He said Dakota County would work with us in order to help us get a flashing light out at the stop light to slow traffic. He also wanted the City to be aware that this is a MN DOT decision and not a county decision.
- He also spoke on the grant money available to do our ordinance book and clarify thing that need to be clarified and other thing that should be taken out that don't pertain to the City of New Trier.
